REVENUE MEMORANDUM ORDER NO. 26-2002

SUBJECT: Revised Allocation of the BIR Collection Goal for CY 2002

TO: All Assistant Commissioners, Regional Directors and Other Officers Concerned

This Order is issued to revise the allocation of the BIR collection goal for CY 2002 among the implementing offices, in view of the adjustment to said goal from \Rho 447,556 M to \Rho 422,516 M. The allocation has also been revised to reflect the reduction and the changes due to the additional one hundred sixty-two (162) excise taxpayers assigned to the Large Taxpayers Service (LTS) from various revenue regional offices. Collection data for the excise taxpayers were taken from ISOS – Data Center. Adjustments for LTDO – Cebu from Revenue Region No. 13 – Cebu were also included.

The revised breakdown by type of tax is as follows:
