**[MUSLIM MINDANAO AUTONOMY ACT 94]**

**AN ACT APPROPRIATING FUNDS FOR THE OPERATION OF THE REGIONAL AUTONOMOUS GOVERNMENT IN MUSLIM MINDANAO FROM APRIL ONE NINETEEN HUNDRED AND NINETY NINE TO MARCH THIRTY ONE TWO THOUSAND, AND FOR OTHER PURPOSES.**

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. Appropriation of Funds. - The amount of One Hundred Twenty Million Pesos (P120, 000,000.00) is hereby appropriated out of the local funds for the operation of the Regional Autonomous Government from April 1, 1999 to March 31, 2000.
