**MUSLIM MINDANAO AUTONOMY ACT NO. 229**

Begun and held in Cotabato City, on Monday, the nineteenth day of November, two thousand and seven.

**AN ACT DIVIDING BARANGAY SALBU IN THE MUNICIPALITY OF DATU SAUDI, PROVINCE OF MAGUINDANAO, INTO TWO SEPARATE, DISTINCT AND REGULAR BARANGAYS, AND FOR OTHER PURPOSES.**

Be it enacted by the Regional Assembly in session assembled:

Section 1. Barangay Salbu in the Municipality of Datu Saudi, Province of Maguindanao is hereby divided into two (2) separate, distinct and regular barangays which shall be known and bounded respectively hereafter as follows:

**TECHNICAL DESCRIPTION**

**A. Barangay Salbu I**

Barangay Salbu I shall partake the nature of a mother barangay. While Barangay Salbu II is the new barangay, which is heretofore created as a result thereof.

Sec. 2. Both barangays shall exercise jurisdiction in all matters provided by the ARMM Local Government Code and other related laws, rules and regulations.

Sec. 3. All officers in the original barangay shall continue to serve their term unless those who reside in the new barangay may transfer thereto.

Both shall however serve their respective unexpired terms until their successors shall have been elected and qualified in the next barangay regular elections.

Sec. 4. Initially, the Barangay Chairman and members of the Sanggunian of the new barangay shall be appointed by the provincial governor of the province of Maguindanao upon the recommendation of the municipal mayor concerned.

Sec. 5. The Commission on Election shall conduct and supervise the plebiscite for the purpose within ninety (90) days after the approval of this Act.

Sec. 6. The division of the barangay shall take effect when approved by the majority of the votes in the plebiscite within the affected areas.

Sec. 7. Such expenses as may be necessary in the plebiscite shall be provided by the municipality concerned.

Sec. 8. This Act shall take effect immediately upon its approval.
