PROCLAMATION NO. 257

RESERVING FOR SCHOOL SITE PURPOSES A CERTAIN PARCEL OF
LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY
OF LAS PIÑAS, PROVINCE OF RIZAL.

Upon recommendation of the Secretary of Agriculture
and Natural Resources and pursuant to the authority vested
in me by law, I, FERDINAND E. MARCOS, President of the
Philippines, do hereby withdraw from sale or settlement
and reserve for school site purposes under the adminis-
tration of the Director of Public Schools, subject to
private rights, if any there be, a certain parcel of
land of the public domain situated in the municipality
of Las Piñas, Province of Rizal, which is more particularly
described as follows:

Lot 1
SWO-40867

A PARCEL OF LAND (Lot 1 of plan SWO-40867,
L.R.C. Record No. _____), situated in the barrio
of Ilaya, Municipality of Las Piñas, Province of
Rizal. Bounded on the SW. and NW., along lines
1-2-3, by Lot 3 of plan SWO-40867; on the NE.,
along line 3-4, by Lot 3 of plan II-5940/a (Roman
Catholic Church); on the SE., along line 4-1, by
Lot 2 of plan SWO-40867. Beginning at a point
marked "1" on plan, being N. 78 deg. 47' W.,
135.40 m. from B.L.L.M. 1, Npl. of Las Piñas,
