PROCLAMATION NO. 83 ✓

DECLARING AS CIVIL RESERVATION FOR THE ILOILO STATE COLLEGE OF FISHERIES; A PARCEL OF LAND OF THE PUBLIC DOMAIN COVERING 19.84 HECTARES, SITUATED IN BARANGAY OLD SAGAY, MUNICIPALITY OF SAGAY, PROVINCE OF NEGROS OCCIDENTAL

Upon recommendation of the Secretary of Natural Resources, and by virtue of the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby declare as civil reservation for the additional school site and Educational Demonstration Farm purposes of the Iloilo State College of Fisheries, subject to private rights, if there be any, a certain parcel of land of the public domain located in Barangay Old Sagay, Municipality of Sagay, Province of Negros Occidental, as shown and described in BFD Map C.R. 374, which is more particularly described as follows:

Beginning at a point designated as corner "1" being N. 19° E., 350 meters from B. L. L. M. No. 1, Sagay Cadastre:

Thence, N. 68° W.,	34 meters to corner 2;
Thence, S. 22° W.,	113 meters to corner 3;
Thence, N. 77° W.,	110 meters to corner 4;
Thence, N. 45° W.,	112 meters to corner 5;
Thence, N. 67° W.,	118 meters to corner 6;
Thence, N. 66° W.,	104 meters to corner 7;
Thence, N. 63° W.,	202 meters to corner 8;
Thence, N. 79° W.,	156 meters to corner 9;
Thence, N. 80° W.,	80 meters to corner 10;
Thence, N. 72° W.,	136 meters to corner 11;
Thence, N. 84° E.,	388 meters to corner 12;
Thence, N. 76° E.,	153 meters to corner 13;
Thence, S. 84° E.,	152 meters to corner 14;
Thence, S. 49° E.,	236 meters to corner 15;
Thence, S. 55° E.,	138 meters to corner 16;
Thence, S. 45° E.,	88 meters to corner 17;
Thence, S. 72° E.,	54 meters to corner 18;
Thence, S. 7° W.,	28 meters to corner 19;
Thence, S. 79° E.,	7 meters to corner 20;
Thence, S. 19° W.,	51 meters to point of beginning,

containing an area of 19.84 hectares, more or less, with the following conditions:

1. The administration and management of the area covered by the reservation shall be under the Iloilo State College of Fisheries.

A five-year development plan shall be submitted to the Office of the President by the Iloilo State College of Fisheries within one year from approval hereof, furnishing the Ministry of Natural Resources and the Bureau of Forest Development copies thereof.

2. The extraction and utilization of timber and other forest products remaining in the area shall be subject to forest and National Internal Revenue Laws and Regulations.
3. In the event that the area is no longer needed for the purposes so stated, or its development has already been abandoned for a period of two (2) years, this proclamation is automatically withdrawn, revoked or cancelled and the subject area shall regain its former status as part and parcel of the public domain.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
