PROCLAMATION NO. 290

DECLARING CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN
SITUATED IN THE CITY OF BAGUIO, ISLAND OF LUZON,
AS TEACHER'S CAMP RESERVATION.

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby declare certain parcels of land of the public domain situated in the City of Baguio, Island of Luzon, as Teacher's Camp Reservation, under the administration of the Department of Education, Culture and Sports, subject to private rights, if any there be, which parcels are more particularly described as follows:

A PARCEL OF LAND situated in the Residence Section "F", City of Baguio. Bounded on the N.E. along lines 3-4-5-6-7-8-9-10 by Forbes Park Reservation (Parcel No. 2); on the S.E. along lines 10-11-12-13-14-15-16-17 by South Drive and Public Land; on the S.W. along lines 17-18-19-20 by Lot 2; along lines 20-21-22-23-24-25 by Forbes Park (Parcel 1); along lines 25-1 by the property of Patricia Tiongson; on the N.W. along line 1-2-3 by Leonard Wood Road. Beginning at a point marked "1", being N. 16-48 m. W., 737.68 m. from Triangulation Sta. "BAGUIO", Baguio Townsite;

Bounded on the N.E. along lines 3-4-5 by Lot 1; on the S.E. along line 5-6 South Drive; on the S.W. along lines 6-7-1 by Forbes Park Reservation (Parcel No. 1); and on the N.W. along lines 1-2-3 by Lot 1. Beginning at a point marked "1" on plan, being N. 3-16'W., 660.77 from Triangulation Sta. "BAGUIO", Baguio Townsite.
