PROCLAMATION NO. 773

DECLARING AS CIVIL RESERVATION FOR THE REGIONAL RESOURCE MANAGEMENT TRAINING CENTER CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN SITUATED IN BARANGAY TAPTAP, CITY OF CEBU

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to Section 18 of Presidential Decree No. 705, otherwise known as the Revised Forestry Code of the Philippines, as amended, I, CORAZON C. AQUINO, President of the Philippines, do hereby declare as Regional Resource Management Training Center Civil Reservation certain parcels of land of the public domain situated in Barangay Taptap, Cebu City, as shown and described as Lots 1 & 2 in FMB Map C.R.-386, which are more particularly described as follows:

Lot 1

A parcel of land beginning at a point marked "1" being N. 23 degrees 02'W., 16370.06 m. from BLLM No. 1, Cad-12 Extension, Cebu Cadastre,

Lot 2

A parcel of land, beginning at a point marked "1" being N 23 degrees 36'W, 16,170.73 meters from BLLM No. 1, Cebu Cadastre,

Thence S 01° 11'W, 43.04 meters to Corner 2;
 Thence S 54° 05'W, 145.77 meters to Corner 3;
 Thence S 70° 38'W, 94.42 meters to Corner 4;
 Thence N 53° 44'W, 42.14 meters to Corner 5;
 Thence N 51° 23'E, 142.96 meters to Corner 6;
 Thence N 53° 47'E, 104.95 meters to Corner 7;

Thence N 86° 20'E, 12.35 meters to Corner 8;
Thence S 62° 49'E, 37.43 meters to Corner 1;

the point of beginning, containing an area of SEVENTEEN THOUSAND ONE HUNDRED FIFTY FOUR (17,154) SQUARE METERS, more or less.


1. The Administration and management of the areas covered by the reservation shall be jointly under the Department of Environment and Natural Resources and the Regional Development Council for Central Visayas. For this purpose, a five-year development plan shall be submitted to the Office of the President by the Resource Development and Management Foundation of Central Visayas, Inc. within one (1) year from the approval hereof, furnishing the Department of Environment and Natural Resources and the Forest Management Bureau copies hereof.

2. The extraction and utilization of timber and other forest product remaining in the areas shall be subject to the Forest and Internal Revenue Laws and Regulations.


3. In the event that the areas are no longer needed for the purpose stated, or their development have already been abandoned for a period of two (2) years, this proclamation is automatically withdrawn, revoked or cancelled and the subject areas regain their original status as parts and parcels of the forest land.
