PROCLAMATION NO. 1554

CREATING AND DESIGNATING SEVERAL PARCELS OF LAND OF THE PRIVATE DOMAIN SITUATED AT CABANGAAN POINT, BARANGAY CAWAG, MUNICIPALITY OF SUBIC, PROVINCE OF ZAMBALES TO FORM PART OF THE EXISTING SUBIC SHIPYARD SPECIAL ECONOMIC ZONE PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995, as amended, and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority, I, GLORIA MACAPAGAL-ARROYO, President of the Philippines, do hereby create and designate; subject to the provisions of Republic Act No. 79 6, as amended, its Implementing Rules and Regulations, and Resolution No. 07-17 dated 09 November 2007 of the Board of Directors of the Philippine Economic Zone Authority, several parcels of land located at Cabangaan Point, Baran ay Cawag, Municipality of Subic, Province of Zambales, to form part of the existing Subic Shipyard Special Economic Zone, with an aggregate area of Eleven Thousand Seven Hundred Twenty Six (11,726) Square Meters, more or less, as defined by the following technical descriptions:
