PROCLAMATION NO. 1936

RESERVING AS RESETTLEMENT HOUSING SITE OF THE MUNICIPAL GOVERNMENT OF MAMBAJAO TO BE KNOWN AS SAINT JOSEPH RESETTLEMENT HOUSING PROJECT, CERTAIN PARCELS OF LAND SITUATED IN SITIO LAGUNDE, BARANGAY POBLACION, MUNICIPALITY OF MAMBAJAO, PROVINCE OF CAMIGUIN, ISLAND OF MINDANAO

Upon the recommendation of the Secretary of the Department of Environment and Natural Resources and by virtue of the powers vested in me by law, **I, GLORIA MACAPAGAL-ARROYO**, President of the Philippines, do hereby reserved certain parcels of land of the public domain for Resettlement Housing site purposes, to be known as Saint Joseph Resettlement Housing, situated in Sitio Lagunde, Barangay Poblacion, Municipality of Mambajao, Province of Camiguin, Island of Mindanao, and more particularly described as follows:

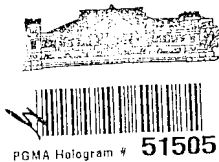
**"Lot 14615, Cad-473
(Ccn-10-000275)**

A PARCEL OF LAND, Lot 14615, Cad-473 identical to Ccn-10-000275, situated in Barangay Poblacion, Municipality of Mambajao, Province of Camiguin, Island of Mindanao.

Bounded on the E., along lines 1-2-3 by Balintawak Creek and legal easement (3.00 m. wide) N., along line 3-4 by Dried Creek, along line 4-5 by Lot 500; along line 5-6, by lot 499, along lines 6-7-8 by Lot 498, and along line 8-9 by existing concrete road, on the E., along line 9-10 by Lot 502 and corner 10 by Lot 503; and along lines 10-11-12 by dried creek; on the S., along lines 12-13-1 by Lot 14608; and on the W., along lines 1-2-3 by Balintawak, all of Cad-473, Mambajao Cadastre;

A PARCEL OF LAND Lot 14507, Cad-473 identical to Lot 2, Ccs-10-000885-D, situated in Barangay Poblacion, Municipality of Mambajao, Province of Camiguin, Island of Mindanao.

Conc. Mons. 15 x 40 cms. and the rest by old BL cyl. Conc. Mons. 15 x 40 cms. Bearing grid. Date of survey, June 28, 2003 executed by Engr. Santos G. Variacion and was approved on March 14, 2003."
