PROCLAMATION NO. 169

RESERVING A PARCEL OF LAND IN SITIO BOBOWA, BARANGAY TABANGOHAY, MUNICIPALITY OF ALANG-ALANG, PROVINCE OF LEYTE, ISLAND OF LEYTE AS TRAINING, RESEARCH AND EDUCATIONAL CENTER UNDER THE ADMINISTRATION OF THE DEPARTMENT OF AGRICULTURE-AGRICULTURAL TRAINING INSTITUTE (DA-ATI)

Upon the recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, **BENIGNO S. AQUINO III**, President of the Republic of the Philippines, do hereby withdraw from entry, sale or settlement and reserve a certain parcel of land of the public domain for the **DEPARTMENT OF AGRICULTURE-AGRICULTURAL TRAINING INSTITUTE (DA-ATI) REGIONAL TRAINING CENTER**, subject to final survey and private rights, if any there be, situated in Sitio Bobowa, Barangay Tabangohay, Municipality of Alang-alang, Province of Leyte, Island of Leyte and more particularly described as follows:

AGRICULTURAL TRAINING INSTITUTE REGIONAL TRAINING CENTER

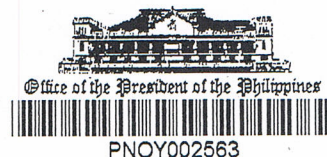
A PARCEL OF LAND (SK-08-000073, MBM No. 18, Cad-220) situated in Sitio Bobowa, Barangay Tabangohay, Municipality of Alang-alang, Province of Leyte, Island of Leyte.

Beginning from a point marked "1" on the plan being S. 81 deg. 04'W., 164.92 m. from MBM No. 18, Cad-220, Tacloban Cadastre, thence:

N. 79-42'E.,	380.22 m. to point 2;
S. 32-27'E.,	331.43 m. to point 3;
S. 27-03'W.,	216.79 m. to point 4;
N. 86-14'W.,	1058.15 m. to point 5;
N. 00-33'W.,	122.53 m. to point 6;
S. 85-18'E.,	580.54 m. to point 7;
N. 05-31'E.,	261.36 m. to point of

beginning. Containing an area of **TWO HUNDRED EIGHTY ONE THOUSAND TWO HUNDRED FIFTY NINE (281,259) SQUARE METERS**, more or less.

The area within timberland shall revert to the mass of the public domain should the same no longer serve the purposes for which it was reserved.
