

"A.C. No. 10804 – (ALBERT V. ABADIES, *complainant* v. ATTY. **DENNIS DON M. SOLIS**, *respondent*). – The Court resolves to **NOTE**:

- the letter dated November 26, 2019 of Atty. Randall C. Tabayoyong, Director for Bar Discipline of the Integrated Bar of the Philippines (IBP) Commission on Bar Discipline, transmitting the documents pertaining to this case; and
- (2) the Notice of Resolution dated March 22, 2018 of the IBP Board of Governors adopting the findings of fact and recommendation of the investigating commissioner, dismissing the complaint.
