“G.R. No. 233205 (People of the Philippines vs. SPO2 Edgardo Menil y Bongkit).- Acting on the letter dated 20 January 2020 of SJ03 Albert C. Manalo, Officer-in-Charge, Documents Section, Bureau of Corrections, Muntinlupa City, informing the Court that accused-appellant Edgardo Menil y Bongkit died on 5 February 2018 at the DPPF Hospital A, Braulio E. Dujali, Davao del Norte as per attached death certificate of accused-appellant Menil, and considering the Decision dated 26 June 2019 which partially granted the appeal and declared accused-appellant SP02 Edgardo Menil y Bongkit guilty of homicide, the Court resolves to:

1. **NOTE** the aforesaid letter dated 20 January 2020 of SJ03 Albert C. Manalo, Officer-in-Charge, Documents Section, Bureau of Corrections, Muntinlupa City; and
